INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA Pursuant to the European Regulation on the protection of personal data 679/2016

The Institute for Biological Systems of the National Research Council, hereinafter referred to as ISB-CNR, provides the following information on the processing of personal data pursuant to Article 13 of Regulation EU Regulation 679/2016. TYPE AND SOURCE OF THE DATA PROCESSED

The registration for participation in the event by users will result in the collection and subsequent processing of personal data provided directly by the interested parties and strictly necessary to attend the event: name, surname, affiliation, address, e-mail address, and current position.

The processing will not concern data of a sensitive nature, pursuant to art. 9 Chapter I.

PURPOSE OF THE TREATMENT AND LEGAL BASIS

The data will be processed for purposes related to institutional, organisational, information and dissemination purposes of scientific activities necessary to fulfil a legal obligation to which the data controller is subject and for the execution of a task of interest to the public or connected to the exercise of public powers vested in the data controller. The data will be processed in accordance with the provisions of EU Regulation 679/2016 and in the D.L. no. 101 of 10 August 2018, which amends and supplements the previous national legislation on the matter. Therefore, the conditions of lawfulness of the treatment exist pursuant to art. 6 paragraph 1 letters c) and e) of EU Regulation 679/2016.

The data provided are mandatory for the achievement of the aforementioned purposes; their missing, partial or incorrect provision makes it impossible for event registration.

METHOD AND DURATION OF THE TREATMENT

The processing of personal data is carried out through electronic tools owned by ISB-CNR.

In relation to these treatments, ISB-CNR has adopted adequate security measures to ensure the data's integrity and confidentiality.

Data are kept for 24 hours after the conclusion of the event and subsequently cancelled.

COMMUNICATION AND DISCLOSURE OF DATA

The collected data will not be disclosed and communicated to third parties except for the requests of the competent Public Security and/or Judicial Authorities based on the law.

The personal data processed will not be transferred to non-EU third countries and/or international organisations.
